Please accept this invitation to consign to one of the longest running consignment sales in Texas. This will be the 45th East Texas/Louisiana Beefmaster Marketing Group sale and governing rules will apply.

You must be a member of the East Texas/Louisiana Beefmaster Marketing Group to consign. If you are not, please enclose a check for \$30 payable to ETLBMG to join or your membership fee can be taken out of your sale proceeds.

Nomination Deadline is February 1, 2025. Fill out the enclosed nomination form and return it with your original breeding certificates. Fees are as follows:

- ~ Consignment Fee - \$50.00 per lot - Applied to the sale expense.
- ~ Screening Fee - \$50.00 per lot - All cattle will be ranch screened, not to exceed \$100.00 per ranch visit.
- ~ Futurity Fee - \$100.00 per lot - Optional for Open & Bred Heifers.
- ~ Display Pens - \$200.00 each (If space is available)
- ~ Display Booths - \$50.00 each (If space is available)

The Heifer Futurity is for Open Heifers, up to 20 months of age and Bred Heifers, less than 30 months of age. Entries must be sent in with consignments and all futurity entries must sell. The futurity will be Friday afternoon. Futurity winners will start the sale, then the sale manager will decide the sale order.

All animals must be 2/3 quality or better to be accepted. Any animal arriving at the sale site not in sale condition will be sifted. All cattle must have a health paper within 30 days of the sale to turn in when you arrive.

Cattle may arrive on Thursday, April 17th from 12:00 pm to 5:00 pm. All cattle must be in place by 12:00 pm on Friday, April 18th.

Guidelines for Cattle Consigned:

- ~ We encourage you to have your birth, weaning, and yearling weights, along with your scan data on all your sale animals. We suggest that all animals are DNA parent verified.
- ~ Herd Bulls & Herd Bull Prospects - 18 months to 48 months of age maximum. **ONLY THE TOP BULLS WILL BE ACCEPTED.** All bulls must be Trich tested and BSE Fertility tested by a licensed vet and stated on the health paper. No virgin affidavits will be accepted. All bulls must have birth, weaning, and yearling weights, SC, Scan Data, and DNA/Parental Verification.
- ~ 3-in-1's or Pairs - Age limited to 72 months of age (6 years). Any female with a calf at side that is over 6 months of age must be palpated safe in calf by a licensed vet and stated on the health paper.
- ~ Bred Cows - Age limit up to 72 months of age (6 years). Bred cows must be heavy bred and stated on the health paper by a licensed vet and of exceptional quality.
- ~ Bred Heifers - Age limit up to 36 months of age. Any heifer over 24 months of age must be palpated safe in calf by a licensed vet and stated on the health paper. Futurity Bred Heifers must be less than 30 months of age.

- ~ Open Heifers - Age limit up to 20 months of age. These heifers will be guaranteed open and certified by a licensed vet and stated on the health paper. Open heifers, that are age appropriate, without birth, weaning, and yearling weights and their scan data will be sold at the end of the sale.
- ~ Special Lots - Donors, Flushes, Embryos, etc. will be accepted. The sale manager will determine where they sell in the sale order.

We ask that you send pictures and/or videos of your consignment for ETLBMG to put on their Website and Facebook. DV Auction will put the videos on their site for \$10. Send all videos to Kevin at www.DVAuction.com.
