**3N1's and Pairs (age limit 72 months)**

**Females with a calf 6 months old are required to be bred back safe in calf.**

**Bred cows (age limit 72 months)**

**Must be palpated safe in calf.**

**Bred and exposed heifers (15 to 32 months)**

**Bred heifers must be palpated safe in calf. Exposed heifers will be accepted and if entered into the futurity will show with the bred heifers.**

**Open heifers (age limit up to 22 months)**

**Open heifers are required to have a weaning weight recorded at BBU.**

**Health Papers (done by a licensed Veterinarian) and be dated within 30 days of the Sale**

**A separate health certificate or copy is required for each lot**

**Animal ID# listed**

**TB and Brucellosis free state status required**

**Bulls Trich tested, BSE tested**

**Females palpation status**

**Health certificates must accompany cattle to the sale facility.**

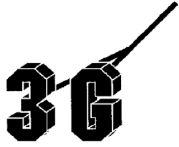
