Seedstock Central 2025 Sale Requirements

- Age Range Of Bulls Accepted:
 - 10/31/2024 (17 months) up to 9/1/2023 (30 months)
- Required Performance Data:
 - BW, WW, YW
 - Ultrasound Scan Data (Lab Certified)
 - Minimum REA 1.0 /100
 - NO CHUTE SIDE DATA WILL BE ACCEPTED.
- DNA - 100K HD Genotype:
 - MUST BE PARENT VERIFIED
 - If bull cannot meet this requirements DNA exemption form must be on file with BBU.
- \$T & \$M EPD:
 - Must be in the top 50% of the breed or higher

- Color Requirements:
 - Red, Black and Dun will be accepted.
 - The following markings will NOT be accepted:
 - NO WHITE blaze face / motley faced
 - NO WHITE on the feet or stocking legged
 - NO WHITE on the tail
 - White tail switch will be allowed
 - If white color is below the drip line of the belly, it will be allowed
 - We strongly recommend keeping the white to a minimum
- Pictures and Video will be required for promotions and needed for catalog
 - Videos and pictures need to be submitted by December 15th for catalog and social media promotions.
 - Promotable type pictures are preferred.
 - Sales Committee will have a list of potential photographers for consignors to use if they need help getting high quality pictures and videos.

2025 Seedstock Central Entry Fee

- Limit 2 Bull Entries Per Consignor
- Prize Money Payout:
