Consignment Requirements

All consignors must be a member of OHOA to consign. Please send \$30 dues payable OHOA to Ty Agee 6264 Rockledge Dr, Memphis, TN 38135. or go to www.ohoabeefmaster.com to become a member.

Consignment must consist of the following
Completed consignment form and signed liability release
Original Breeding Certificates or copies

Catalog Fees- \$100 per lot, refunded if your cattle sell.

Futurity Fee- \$100 per entry, Non-Refundable

The fees must accompany all consignments- no exception

Health Certificates- Cattle must be listed on the Interstate Health certificate by a licensed veterinarian with the animals permanent ID (traceability requirements).

The cattle must be listed on a health certificate with ID's and palpation. Semen test and scrotal circumference on bulls and palpation on females must be shown on the health certificate. Testing must be done within 30 days of the Sale date. All bulls must pass a Breeding Soundness Evaluation (BSE). The BSE must be filled out by the licensed Veterinarian. A separate health certificate is required on each animal. (Copies accepted). Health certificates must list the following:

- 1) Brucellosis (Females) and TB testing unless you are from a Free State.
- 2) All bulls must be Trich tested (negative test attached), fertility tested, scrotal Circumference and listed on the BSE form.
- 3) Palpation on females listed.
- 4) Females must be calthood vaccinated for Brucellosis and the information listed on the health certificate.
- 5) Testing must be done within 30 days of the Sale date and the health certificate
Must accompany the cattle to the Sale.

This Sale is open to futurity bulls, graded bulls, 3n1's, pairs, bred cows, graded bred heifers, and open futurity heifers. The following rules apply to each category. No advancer cattle will be accepted into the Sale.

Futurity Bulls - Named Larry Buster Bull Futurity. All futurity bulls MUST have been born between February 15 and April 15th, 2025. Only one animal per consignor in this category.

Futurity Bulls- Must have an official 205 day weight , yearling weight and ultrasound data recorded with BBU prior to April 1st, 2026. The scrotal circumference must be written on the health papers. Bulls not weighing more than 900 pounds at the time of judging will not make the Sale.

Graded Junior & Senior Bulls- Junior division age July 1 to December 31, 2024. Senior division age January 1 to June 30, 2024. Bulls must have an official 205 day weight , yearling weight and ultrasound data recorded with BBU

Only 2 consigned bulls per consignor will be accepted. Any combination of category but only one yearling futurity bull. All bulls must be polled or dehorned.

Futurity Open Heifers- Named Tom Hood Open Heifer Futurity. Senior division age December 15, 2024 to February 14, 2025. Junior division age February 15 to April 15, 2025. Heifers must have an official 205 day weight , yearling weight and ultrasound data recorded with BBU prior to April 1st, 2026.

3N1's and Pairs- Maximum age is 84 months (7 years). Any female with a calf at side that is over 6 months of age must be bred back. The oldest a calf at side can be is 10 months.

Bred Cows-36 months to 84 months of age. Only the highest quality will be accepted. Bred cows must be bred 90 days or more at Sale date.

Graded Bred Heifers- Age limit must be bred to calve by 36 months.

Picks- Animals in pick lots must be at least ½ siblings.

The Sale committee will screen all cattle at the Sale site before being allowed to sell. Screening will consist of feet, legs, udder, muzzle, navel, disposition, conditioning, etc.

Consignors are responsible for making sure their consignments have correct ID's and are stated as such on the Health certificates.

There will be no refunds of catalog or futurity fees for no shows or animals removed from the Sale by the screening committee.
