4. The entry must be less than 30 months old day of sale.
5. The entry must have scan data available before the sale.
6. The entry must have a genotype (30 ULD) before the sale.
7. The fee to enter is \$150.00 & catalog fee \$50.00.
8. There will be one judge selected by SEBBA sale committee
9. There will be two classes: Open and Bred
10. Minimum 1 inch ribeye per pound recommended
11. At least a 2% IMF recommended
