- * DVauction will broadcast the live internet of the sale.

DEADLINE TO CONSIGN: September 15, 2026.

Consignments must consist of:

- * Completed consignment form
- * Signed liability release
- * Check for applicable fees

Bulls: Age must be within 13 to 36 months

Females; Must be less than 78 months old at day of Sale. Any cow with a calf 6 months of age and older must be bred back. Heifers 20 months of age and older must be bred.

Bred Cows: Must be less than 78 months and bred in the 3rd trimester (6-9) mos.

Open Heifers: Must be less than 20 months old to sell as open.

Miss South Texas Pageant Guidelines:

The pageant will have 2 categories. We will accept open and bred heifers. Heifers must be bred and owned by the Consignor.

Nomination Fee: \$100 per heifer nominated.

Open Heifers: No open heifers born before March 15, 2025 will be accepted.

Bred Heifers: Cannot be older than 30 months on Sale Date. No exposed heifers will be accepted into the pageant. If calved the calf must be less than 30 days. If the calf is older than 30 days the heifer will not show but can sell in the regular Sale.
